

Khirbat al-Buwayra



Khirbat al-Buwayra - Depopulated Palestinian Village of the Ramla Subdistrict

Khirbat al-Buwayra was a Palestinian village in the Ramla Subdistrict, approximately 15 kilometers southeast of al-Ramla. It stood on a hilltop and extended along both sides of a wadi surrounded by lower hills and valleys, at an average elevation of about 250 meters above sea level.

A dirt road linked the village with the Ramla–Ramallah road, which passed less than two kilometers to the east, while additional tracks connected it with neighboring villages. The locality gradually developed into a small agricultural village whose closely clustered stone-and-mud houses were separated by narrow lanes.

Location

Khirbat al-Buwayra stood on a hilltop and spread along both banks of a wadi amid lower hills and valleys.

A dirt track connected it with the Ramla–Ramallah highway less than two

kilometers to the east, while local roads linked it with neighboring communities.

The village occupied part of the eastern Ramla countryside leading toward al-Latrun and the western approaches to Ramallah.

Neighboring Localities

Khirbat al-Buwayra formed part of a dense network of villages and khirbas in eastern Ramla Subdistrict. Nearby localities included Bir Ma'in, Bayt Sira, Bayt Nuba, Bayt Shanna, Salbit, and Ajanjul, together with the villages of the al-Latrun area.

The armistice line subsequently drawn between Israel and Jordan passed close to the former village.

Development and Housing

Families came from the surrounding region to establish farms at Khirbat al-Buwayra and gradually built permanent houses there.

The houses were constructed of stone and mud, clustered relatively close together, and separated by narrow lanes.

All of the village's inhabitants were Muslims.

Population in 1931

The official 1931 Census of Palestine recorded **101 inhabitants** at Khirbat al-Buwayra.

They lived in **17 houses**.

Population in 1944/1945

Khirbat al-Buwayra had approximately **190 Palestinian Arab inhabitants** in 1944/45, all of them Muslims.

The figure indicates substantial growth from the 1931 census total.

Estimated Population in 1948

Salman Abu Sitta's Register gives an estimated **220 inhabitants** for Khirbat al-Buwayra in 1948.

This is a retrospective demographic estimate and not an official census conducted in 1948.

Land Ownership in 1944/1945

The village possessed a total of **1,150 dunums**.

The entire registered village land area was therefore recorded in the Arab category in the late-Mandate statistics.

The 25 dunums of olive groves were a subset of the 31 dunums classified as plantations and irrigable land and should not be added to the total a second time.

Economic Life

The villagers relied primarily on agriculture and livestock raising.

They cultivated cereals, vegetables, and fruit. Some crops were rain-fed, while others were irrigated from wells scattered throughout the village lands.

Part of the village land was also used as grazing ground.

Water

The inhabitants obtained domestic water from a well within the village site.

Several additional wells were dispersed across the surrounding land and supplied water for irrigated plots and orchards.

These wells remained among the most visible features of the former village site in later field descriptions.

Olive Groves and Orchards

Thirty-one dunums were classified as irrigated or planted land, including approximately **25 dunums of olive groves**.

Fruit and vegetables were also cultivated with water drawn from the village wells.

Archaeological Khirba

On the outskirts of the village was an older khirba carrying the same name.

It contained the foundations of a rectangular building equipped with cisterns, indicating earlier occupation of the site before the development of the modern Palestinian village.

Operation Dani

Operation Dani began on **9 July 1948** and continued until **18 July 1948**.

It was the largest Israeli offensive of the “Ten Days” between the First and Second Truces.

The operation unfolded in two stages:

- **First stage, 9-12 July:** the occupation of Lydda and Ramla and surrounding localities.
- **Second stage, 13-18 July:** the advance eastward toward al-Latrun and Ramallah and efforts to control the Ramallah–al-Latrun road.

PalQuest explicitly lists Khirbat al-Buwayra among the localities affected by Operation Dani.

Occupation and Depopulation

After Lydda and Ramla had been occupied and their inhabitants expelled, Israeli forces pushed eastward toward al-Latrun during the second phase of Operation

Dani.

Walid Khalidi considers it probable that Khirbat al-Buwayra was occupied during this advance in **mid-July 1948**.

No detailed independent account survives describing the precise entry of troops into the village or the departure of each family.

Salman Abu Sitta's updated Register gives **14 July 1948** and also describes the timing as “mid-Jul-1948,” while Palestine Remembered and several other Palestinian sources use **15 July 1948**.

This article therefore uses the formulation **14-15 July 1948 / mid-July** and preserves the difference between the sources.

Military Unit

Several brigades participated in Operation Dani at the operational level, including Har'el, Yiftach, the Eighth Armored Brigade, Kiryati, and Alexandroni, while PalQuest also lists Etziyyoni among the wider participating forces.

During the second phase, the **Har'el Brigade** was tasked with taking villages farther east on the al-Latrun axis.

Khalidi's village entry, however, explicitly states that no detailed account of the occupation of Khirbat al-Buwayra is available and does not identify a specific attacking brigade.

The most accurate formulation is therefore:

Executing military unit: not independently documented at village level; the Har'el Brigade was the principal force assigned to the eastern axis during the second phase of Operation Dani.

Occupation and Displacement Chronology

Stage	Date	Details
Pre-Nakba Village	Until July 1948	A small agricultural village whose final official prewar population was 190, with a later 1948 estimate of 220.
Beginning of Operation Dani	9 July 1948	The major offensive aimed at Lydda, Ramla, and the approaches to Jerusalem began.
Occupation of Lydda and Ramla	10-12 July 1948	The two cities were occupied and most of their residents expelled, after which forces shifted eastward.
Beginning of the Second Phase	13 July 1948	The advance toward al-Latrun, Ramallah, and villages along the eastern axis began.
Occupation and Depopulation of Khirbat al-Buwayra	14-15 July 1948	The occupation occurred in mid-July; Abu Sitta gives 14 July while several other Palestinian sources give 15 July.
End of Operation Dani	18 July 1948	The attempt to capture al-Latrun failed, but numerous Palestinian villages had come under Israeli control.

Cause of Displacement

The displacement of Khirbat al-Buwayra's inhabitants was directly connected with the military advance during the second phase of Operation Dani.

The principal sources do not establish whether every resident fled during the fighting or whether some were expelled immediately after Israeli forces entered the village.

The most supportable description is therefore **displacement as a result of military assault and the occupation of the village during Operation Dani.**

Extent of Destruction

Khirbat al-Buwayra was reduced to rubble scattered across a broad area after the Nakba.

Walid Khalidi's field description records only the walls of one large house, built of relatively large stones, as still standing.

No reliable numerical destruction percentage is available, so the village is not assigned an unsupported figure such as "100 percent destroyed."

Israeli Settlements on Village Land

No Israeli settlements are documented on the lands of Khirbat al-Buwayra by Walid Khalidi or PalQuest.

No neighboring settlement is therefore assigned to village land solely on the basis of geographic proximity.

Khirbat al-Buwayra Today

The available site description is based on historical field research incorporated into Walid Khalidi's *All That Remains* and does not constitute direct field verification in 2026.

According to that description, rubble from the village is scattered across a wide area, while portions of the walls of one large stone house remain standing.

The center of the site contains several wells and former private gardens divided by stone markers, some of which also serve as steps descending into the wadi.

Almond, fig, olive, and pine trees once grew in the center of the site, but a fire in 1989 destroyed many of them.

In Khalidi's last documented description, the former village site was being used as a **military training area**.
